### WOMEN IN PRIVATE EQUITY AWARDS 2018 (EUROPE)

The awards are designed to find the most exemplary women within private equity across Europe to recognise the support and contribution women they make to the private equity sector.

All the categories are open to employees at all levels, as well as business owners. Self-nomination is not permitted; nominations have to be made by an employer or someone other than the nominee working within the same company.

It is possible that a nominee would have worked as part of a team or made substantial contributions at another firm, it is essential that the information provided on the nomination form clearly stating the role and contribution of the nominee at these firms.

Nominees can reserve the right to withdraw their nomination. However if a nominee drops out after the finalists are announced the nominating company would still be liable to pay the finalist fees.

Nominees must be currently working within the private equity Industry and have a minimum of 2 years' experience within the industry.

Initial finalists' selection is done entirely online, please ensure supporting evidence is viewable online. Finalists will be notified and required to attend the judging day. Please ensure your nominee if shortlisted can attend the judging day there will be no other option to have the interview with the judges.

Finalists would also have to commit to attend the awards ceremony

## REVIEW PROCESS

### THE FIRST PART OF THE REVIEW PROCESS THE JUDGES WILL BE SCORING ON:

1. How well the application met the individual criteria for the category they are being nominated for.
2. How strong their achievements/successes/initiatives are compared to industry and role benchmarks.
3. How unique their submission is compared to other nominations.
4. How well their submission and evidence is weighted against the criteria.
5. How robust the evidence submitted is.

### FOR THE SECOND PART OF THE PROCESS THE JUDGES WILL BE SCORING ON:

- INVOLVEMENT IN & COMMITMENT TO THE INDUSTRY  
Industry achievements, role model for other women in the industry
- CAREER & EDUCATION  
Current role and employment history, education and further training relevant in the PE industry
- TEAM WORK & LEADERSHIP SKILLS  
Leadership skills, ability to operate effectively in a team or unassisted, contributing positively to team operations and working relationships
- PROFESSIONAL ACCOMPLISHMENTS  
The most significant professional accomplishments in the past 12 months
- ADVOCACY AND INFLUENCE  
Their impact and success with PE industry
- OTHER PURSUITS, HOBBIES & EXTRACURRICULAR ACTIVITIES  
Achievements in areas other than study and work.



## ELIGIBILITY

To be eligible, candidates must:

- Be employed by the company nominating them.
- Be working within Private Equity.
- Be nominated by their employer.

Nominations are FREE to enter. All we ask, is for companies to commit to purchase a minimum of 3 seats to attend the awards dinner. One for the nominee and two other guests to support her on the night. Companies can also purchase more than 3 seats if they prefer.




